- 1. Artists may enter up to five original art works. A maximum of one piece may be marked "NFS" meaning "Not for Sale."
- 2. Maximum size for hanging items is 30"x30" including the frame. Maximum size for standing items (i.e., sculpture) is 30"x30" and 48" in height.
- 3. All items must be delivered to Gallery 413 between 11:00 am and 3:00 pm October 26 or 27 unless other arrangements have been made.
- 4. Ending date of exhibit will be determined based on winter schedule for the Gallery. Pick-up dates and times to be announced.
- 5. The Crisfield Arts Syndicate reserves the right to reject submissions deemed unsuitable for the exhibit.
- 6. The Crisfield Arts Syndicate and Gallery 413 are not responsible for loss or damage to works, but reasonable caution will be taken.
- 7. The Crisfield Arts Syndicate will take 20% commission for members and 25% for nonmembers on all work sold during the exhibit or as a result of the exhibit.
- 8. Unless other arrangements have been made, all items not removed after 30 days of stated pickup date become property of the Crisfield Arts Syndicate and Gallery 413.
